ODH is proposing to amend this rule to set graduated application fee increases to go into effect on July 1, 2010 and July 1, 2011.

The rule establishes application requirements for initial approval of nurse aide

training and competency evaluation programs. These requirements include, but are not limited to, documentation of qualifications of a program coordinator and instructors, location and description of facilities where training will be provided, and a nonrefundable application fee. The rule is being amended to increase the application fee from \$200 to \$250 effective July 1, 2010 and to \$300 effective July 1, 2011.

The NATCEP fees have not been increased since they were established in 1990. These fees are used to cover the cost of reviewing and approving training programs, including checking teaching and work experience qualifications, and on-site visits to training classes to evaluate compliance with regulatory requirements. The NATCEP program approved 34 initial applications in FY 2009. Based on FY 2009 rates, the proposed initial application fee increase will generate approximately \$1,700 in FY 10. These fee increases will not cover the entire cost of the program, but will minimize the current GRF subsidy level of \$287,875 to \$286,175.

The NATCEP programs pay fees every two years. These programs are either nursing home based or freestanding such as vocational schools and state colleges. These increases will be implemented incrementally through \$50 increases effective in July of 2010 and July of 2011.
