The rule states the application requirements that must be met by a person or entity in order to obtain approval of a Training and Competency Evaluation Program. The rule is amended in order to: 1 require Medicare and Medicaid certified applicants to include their facility numbers in the applications; 2) only require applicants to submit one typed original of the application to the Director of Health, as opposed to an original and one copy; and 3) give the Director or his/her designee sixty (as opposed to ninety) days from receipt of an application to mail written notice of proposed approval or denial to each applicant.
