ODH is proposing this rule as part of the five year rule review required by section 119.04 of the Revised Code.

The rule sets forth the general post-approval requirements for training and competency evaluation programs. These requirements include, but are not limited to, reporting to the director those students who complete a program and reporting any changes to the program at least ten business days prior to any change.

Amendments have been made to require reporting to the director when the NATCEP's demographics have changed to ensure ODH has updated information, and to remove outdated language requiring written notification.

This rule requires notification to the director as follows:

1) 7 days prior to beginning scheduled training; 2) 10 days prior to certain curriculum changes, 3) demographic changes, and site changes; 4) 45 days prior to curtailing training activities; and 5) Within 7 days following the completion of a program, names of individuals that completed the program so those individuals may sit for the state test.
