ODH has reviewed this rule pursuant to R.C. 119.032 (five-year review), and is proposing it with amendments.

This rule states the application requirements that must be met by a person or entity

in order to obtain initial approval of a Train-the-Trainer program. The proposed amendments give the Director or his/her designee sixty (as opposed to ninety) days from receipt of an application to mail written notice of proposed approval or denial to each applicant.
