This rule sets forth requirements for the scheduling and administration of the state-administered competency evaluation program. These requirements include, but are not limited to, the director notifying registrants of location and time of tests and the registrant presenting valid government issued ID in order to take the test. The rule has been amended to clarify the types of documentation to be provided for proof of identity and to allow applicants to use calculators when taking the test.
