This rule has been reviewed to satisfy five-year review requirements and is proposed with amendments to add one disease and to remove two from the reportable disease list.

This rule lists the diseases that physicians, laboratories, hospitals, and other healthcare providers must report to public health. The proposal specifically adds a disease that is reportable (i.e. "Zika"), and removes two diseases. Zika is currently reportable under a general category; however, specifically listing the disease as a reportable disease removes any potential confusion about whether it is reportable.
