ODH is recommending that one disease (Candida Auris) is added to the reportable disease list, and specifically list Salmonella Paratyphi infection under Class B disease, which is currently reportable under salmonellosis. Specifically listing this disease reportable removes any potential confusions about whether it is reportable. In addition, ODH proposes to move yellow fever from a Class A to a Class B disease, and to rename typhoid fever as Salmonella Typhi infection (typhoid fever). These additions and changes are proposed to be consistent with the 2019 national notifiable disease list.

The rule lists those reportable diseases that physicians, laboratories, hospitals, and other healthcare providers much report to public health. The proposal specifically adds a disease ("Candida auris") as reportable and renames/reclassifies three other diseases.
