O.A.C. rule 3701-3-29 has been reviewed pursuant to five-year review requirements, and it is being updated with current Ohio veterinarian guidance and recommendations. Due to number of changes, ODH is rescinding the current rule and replacing it with this new version.

This rule sets forth requirements for quarantining or, when appropriate, euthanizing mammals that have bitten humans, or otherwise exposed them to rabies. It also sets procedures when mammals are bitten by known rabid mammals. Finally, the rule gives the health commissioner of each health district jurisdiction in matters of quarantining or euthanizing mammals. The proposed changes update the rule to be consistent with current Ohio veterinarian guidance and recommendations. Due to the number of changes, ODH is rescinding the current rule and replacing it with this new version.
