To comply with Substitute Senate Bill 121/124 G.A. which revises the law requiring screening of newborn children. The revisions require the Director of Health to promulgate the rules instead of the Public Health Council, as in previous law.

Requires all newborn children to be screened in accordance with the procedures set forth in Chapter 3701-45 of the Administrative Code for the presence of 12 specific genetic, endocrine, or metabolic disorders.
