Proposed new O.A.C. Chapter 3701-45 will implement an earmarked program for assisting low income families with the purchase of hearing aids funded by the Ohio Legislature in Section 285.20 of Amended Substitute House Bill 59 (Am. Sub. HB

59) of the 130th General Assembly.

Rule 3701-40-03 outlines the eligibility requirements for families to apply for assistance for their children under this program and describes the application process.

Although \$200,000 has been set-aside for this program for each year of the current biennium, the only cost to the agency will be an estimated \$1,250 for development of an RFP, preparation of a contract, and contract oversight. The earmarked funds (\$200,000) will be used to provide services to families, publicity for the program, and contractor oversight of applications, hearing aid purchases, and reports of expenditures to the Department of Health. There will be no additional cost to the agency.

15. Provide a summary of the estimated cost of compliance with the rule to all directly affected persons. When appropriate, please include the source for your information/estimated costs, e.g. industry, CFR, internal/agency:

This program will require completion of an application by the family and proof of income. With an average time of 30 minutes to complete the application and another 15 minutes to procure a copy of the verification of income, cost per family application would be \$18.75 (45/60 X \$25).

The fees set for providers within this program should cover their basic costs for processing the application, making ear molds, and fitting the hearing aids to the child so the net impact on them in terms of cost to provider should be zero.

Families must provide proof of annual income below 400 per cent of the applicable Federal Poverty Level in order to be eligible for the program.
