This rule sets forth the conditions under which a home may transfer or discharge a resident and the resident's right to a hearing to challenge that transfer or discharge. The rule has been amended to add language clarifying that an individual may not be discharged while they are awaiting the outcome of an application or appeal of an application with Medicaid and to clarify that a discharge for the safety of individuals is based on the resident's behavior and clinical status. Finally, the rule has been amended to remove regulatory restrictions in accordance with SB9.
