Page 2 Rule Number: 3701-61-03

This rule establishes the resident notice and hearing request requirements for homes seeking to transfer or discharge a resident. The proposed changes 1) allow a home to provide the 30-day notice of transfer to a resident to a proposed location without that location having already accepted the resident; and 2) requires the 30-day notice to inform the resident and the resident's sponsor that they may choose another location to which to relocate the resident.
