The rule has been amended to allow the administrator of the home to send notices by email in addition to certified mail, to collect the contact information of the administrator, including an email address, and to require documentation of medical reasons for discharge to be documented in a resident's medical record as applicable. Finally, rule has been amended to remove regulatory restrictions in accordance with SB9.
