The rule establishes the transfer and discharge responsibilities of nursing homes. These requirements include providing adequate notice to the individual and/or their

representative and ensuring acceptance by the receiving facility; providing written notice to Medicaid recipients being transferred to a hospital or for therapeutic leave, specifying the number of days, if any, during which the resident will be permitted under the Medicaid program to return and resume residence in the home and specifying the Medicaid program's coverage of the days during which the resident is absent; and providing written notice to those individuals not receiving Medicaid, of the home's written policy regarding the resident's option to pay privately in order to hold a bed until the resident is able to return. The rule is being filed without changes.
