This rule sets forth the requirements for a safe and orderly transfer or discharge of a resident from a home, including adequately preparing a resident prior to transfer or discharge. Additionally, this rule sets forth "bed hold" requirements where a home must hold the bed of a resident who has been transferred or discharged to either a hospital or to therapeutic leave for a number of days until the resident is able to return. The rule has been amended to require that arrangements for the residents medication, treatment plans, medication and necessary services be arranged for, allow email notification of a hearing in addition to certified mail, and to remove regulatory restrictions in accordance with SB9.
