ODH has reviewed this rule to meet the five year review deadline, and is proposing it with amendments.

This rule lists various ways in which a person may revoke his or her DNR identification, including, but not limited to, destroying the DNR form or wallet

card; permanently removing DNR jewelry; and revoking a declaration intended to be used as a DNR identification. The rule is amended to require every attending physician, certified nurse practitioner, and clinical nurse specialist that issues an order discontinuing a valid DNR order to ask the patient prior to discharge or transfer whether he or she wants to make another DNR declaration.
