The rule sets forth the requirement that physicians, CNPs, CNSs, or health care facilities that are unwilling or unable to comply with a person's DNR, to not interfere with the transfer of the person to a provider who will follow the DNR protocol. The rule is being revised to include physician's assistants and the authority and immunities granted under section 2133.211 of the Revised Code pertaining to physician assistants became effective with the enactment of House Bill 284.
