The five year review of Ohio Administrative Code Chapter 3701-64 is due to be completed by May 1, 2011. The Ohio Department of Health is seeking amendment of rule 3701-64-04 at this time.

The rule sets forth the requirements for hearings on allegations of abuse, neglect, or misappropriation. These requirements include, but are not limited to, the director

appointing an attorney as a hearing officer, the director may issue subpoenas, and the hearing officer must submit a written report of the hearing to the director. The rule is being amended to remove the term "working" in paragraph (I) of rule 3701-64-04 when referring to the number of days a hearing officer has to deliver a written report to the Director. This revision will provide consistency with references to days in the subsequent paragraph and in similar rules in the Administrative Code.
