Unable to estimate the cost of compliance, county family and children first councils are responsible for implementation and monitoring of the Help Me Grow (HMG) program locally. Funding for HMG is provided by the departments of health, job and family services and mental retardation and developmental disabilities. Due to the variety of services provided for program participants locally, it is not possible to determine the full cost of this program statewide. Base funding is provided to each county, but many counties also leverage local resources to expand services to families. The state allocation formula for funding to the counties includes an amount of \$1480 per child. However, actual costs vary depending on each child's and family's needs.

There are no new program requirements imposed by the proposed rule. Additional state and federal funding is provided to counties for HMG services to newborns and infants and toddlers at risk for or with developmental delays or disabilities. Due to the variety of services provided for program participants locally, it is not possible to determine the full cost of this
