Rule 3701-8-03 is new and lists the minimum education and training requirements for personnel working within Help Me Grow. This rule explains the minimum education required to be hired, expectations for training, requirements for obtaining initial credential and renewal every two years. Finally, it incorporates requirements which were previously in HMG program policy.

The department will spend approximately \$300,000 on training in the upcoming biennium. These expenditures will be supported with existing resources and are necessary in order to provide the trainings required for supervisor, home visitor, and service coordinator credential.

The cost of compliance will vary depending on the number of already-credentialed staff employed by each contractor. Those individuals already credentialed must obtain 20 contact hours of training over two years. Individuals who are not yet credentialed will cost contractors time away from productive work to be trained. There are two required trainings in person for service coordinators and home visitors which may require costs or hotel accommodations and mileage reimbursement, when the training requires travel out of county.

  - Help Me Grow is a voluntary program, but requires a contract, grant, or agreement to participate and seek reimbursement.

  - Each individual utilized as a supervisor of home visitors or service coordinators, a home visitor, or a service coordinator shall meet the education and training requirements set forth in this rule and maintain such credential without lapse. If a home visitor or service coordinator serves families in HMG before the supervisor, home visitor, or service coordinator obtains the HMG credential or after a credential lapses, the department may take any of the actions listed in paragraph (B) of rule 3701-8-02.1 of the Administrative Code.
- C.) Does this rule require specific expenditures or the report of information as a condition of compliance? Yes

This rule requires that home visitors and service coordinators are credentialed before they are qualified to serve families in Help Me Grow. These requirements were previously in HMG program policy and were moved to rule so that program policy will no longer exist and all requirements will be in OAC. The federal regulations for Early Intervention require that personnel be qualified and that the lead agency (ODH) have processes in place for assuring that personnel are qualified. In order to become credentialed, trainings may cost the contractor some

money, although the ODH has subsidized or paid for the majority of required trainings and will continue to, even when this rule goes into effect. Most trainings cost nothing because they are available on demand and on-line. Additionally, contractors must ensure that their hired or sub-contracted employees providing HMG services input their information into the Ohio Professional Registry as a condition of obtaining their credential.

This rule requires that service coordinators and home visitors meet the educational and training requirements for a department-issued, HMG credential. The estimated cost of fulfilling the training requirements for this credential include time away from work, travel and overnight accommodations, when necessary. Credentialed personnel have met these requirements, but if a new individual is hired, they have to become credentialed before being allowed to serve families. In cases of required in-person trainings (1 # 3, depending on role requirements; all others are available on-line, free and at whenever the learner is available), materials are paid for by ODH, but estimated costs for one two day training, which is required for all personnel, is \$1300 (salary/fringe) + \$500 (hotel) + \$100 (car mileage) = \$1900.

The estimated cost is time away from work, travel and overnight accommodations for every individual who needs the required two day training institute training. These trainings are offered throughout the state, but in instances where individuals must travel more than 60 miles, the estimated two day salary & fringe, overnight accommodations, and roundtrip mileage are: \$520 (salary/fringe) + \$100 (hotel) + \$60 (car mileage) = \$780.

Through a subsidy agreement with ODH, the department will be providing \$2500 per credentialed home visitor, which will offset the training costs for training and costs incurred because of the need to travel for the Training Institute or affiliation-related training.

Faxing, scanning, or copying costs associated with sending proof of trainings to the Ohio Professional Registry, as required to meet the requirements of the home visitor credential.

Through a grant for Service Coordination contractors with ODH, grantees budget for travel and training expenses as expected for their staff of service coordinators. Training costs are legitimate expenses and thus reimbursed as expenditures are reported to the department from grantees.
