The rule is being proposed due to updates and clarifications related to federal Early Intervention regulations, the inter-agency partnership between DODD and ODH to lead Early Intervention; and to simply the requirements of existing rule.

then summarize the content of the rule:

Rule 3701-8-07 is amended to simplify the eligibility categories for Early Intervention from five to three. Because the rule was amended with input from the Ohio Department of Developmental Disabilities and stakeholders, the rule should reduce confusion about screening, determining eligibility and assessing infants and toddlers, as required in the federal Individuals with Disabilities Education Act, Part C program (Help Me Grow Early Intervention) 34 C.F. R. Parts 300 and 303.

The net impact is an increase in expenditures, due to the technical assistance and training for Evaluation & Assessment, IFSP process and outcomes, and EI Services moving to the Ohio Department of Developmental Disabilities. This money pays for their four program consultants, an EI administrator, and support staff; as well as contracts for training development, technology, and travel. These expenditures will be supported with existing resources. Please also note that the funds provided through a grant to the 88 county Family & Children First Councils is provided in the RSFA for Rule 3701-8-07.1.

Help Me Grow is a voluntary program, but requires a contract, grant, or agreement to participate and seek reimbursement from ODH. Moreover, in order to conduct evaluations or assessments on infants or toddlers to determine eligibility and/or need for early intervention services; an individual be licensed to perform the scope of services in accordance with Ohio law. That license may be in any of the following: counseling; early childhood education, when licensed for ages three through eight, grades kindergarten through third, or in special education; early childhood mental health; early intervention; hearing impairment intervention; medicine; nursing; occupational therapy; physical therapy; psychology; psychiatry; social work; speech-language pathology; and visual impairment intervention.
