The net impact is an increase in expenditures, due to the processing of provider and family/child applications, denial and acceptance communications, establishing financial and program eligibility and monitoring of both providers and annual applications for services. Agency impact calculated with salary and fringe costs for one EI program consultant at 50% of their time and one support staff at 30% of time for the year remaining year in this biennium. The department staff resources total \$50,000 and will be supported with existing resources. The \$300,000 is held at the department to pay out invoices from the providers of services once rendered and is an estimate of the money needed, based on what the department has paid to providers over the past three years.
