This rule sets forth general provisions and prohibitions applicable to health care services. For example, the rule states that no person or agency can operate a health care service that does not comply with the requirements of Chapter 3701-84; prohibits persons or agencies from interfering with the Director of Health's inspection or investigation of an HCS; and requires every provider to ensure that the building where the HCS is located is in compliance with all applicable federal, state, and local laws. The proposed amendments clarify what constitutes "interference" with an inspection or investigation of an HCS.
