ODH is amending this rule to reflect changes in penalty fees adopted in HB 487 of the 129 G.A.

This rule establishes criteria for individuals seeking certification as radiation experts. Section (N) is amended to parallel new statutorily established penalties.

This rule requires an individual to meet educational requirements to be certified as a radiation expert.

This rule applies to a late penalty for payments of renewal applications. the current rule revision is to reduce the late fee penalty to 10 percent of the original renewal invoice fee in support of HB 487. Previous penalty fees were two times and five times the original invoiced fee.

This rule requires reporting evidence of initial education and continuing education requirements to meet the qualification of a certified radiation expert and an application fee for certification.
