This rule is being proposed due to the required five-year review and to update the rules to be consistent with the current version of the Food and Drug Administration's (FDA) Model Food Code. Section 3717.05 (B)(1) of the Revised Code requires the Ohio uniform food safety code to be based on the most current version of the FDA model food code.

7. **Summarize the rule's content, and if this is an amended rule, also summarize the rule's changes.**

3717-1-01 provides definitions of the terms used in Chapter 3717-1. Changes to the rule include: eliminating hanging sentences; putting the definitions in alphabet order; correcting the definitions (easily movable, packaged, restricted egg, safe material, slacking) to be consistent with FDA's Model Food Code; correcting the definitions of general use pesticide and restricted use pesticide to be consistent with the Ohio Department of Agriculture's law; correcting a typo of coli in Shiga toxin-producing Escherichia coli; correcting references in time/temperature controlled for safety food; amending dates of reference documents; and clarifying who is the regulatory authority in the definition of variance.
