Ohio Revised Code Section 3717.05 requires the Director of Agriculture and the Public Health Council to base the Ohio Uniform Food Safety Code, which is the statewide standard for food safety in food service operations and retail food establishments, on the most current version of the FDA Model Food Code. These amendments or changes are proposed to ensure that the Ohio Uniform Food Safety Code continues to conform to the FDA Model Food Code.

This rule concerns the responsibilities of management with respect to disease or medical condition reporting by food employees and applicants. Because of extensive changes made to comply with the 2005 Model Food Code and Supplement, the current OAC 3717-1-02.1 is being proposed for rescission and a new OAC 3717-1-02.1 is proposed.
