Section 3717.05 of the Ohio Revised Code requires the director of agriculture and the director of health to adopt, amend, or rescind provisions in the Ohio uniform food safety code to ensure that it continues to conform to the federal food and drug administration's model food code. The changes proposed are the result of the most recent changes to the federal code, and they fulfill five-year review requirements.

The purpose of the rule is to provide the license holder the requirements on the personnel cleanliness of the employee. Changes to the rule include: to require a food employee who is donning gloves used for task that involves working with food to wash their hands; and revised the rule dealing with hand antiseptics to conform to the FDA code.
