This rule is being proposed due to the required five year review as well as updating the rules to be consistent to the current version of the Food and Drug Administration's (FDA) Model Food Code. Section 3717.05 (B)(1) of the Revised Code requires the Ohio uniform food safety code to be based on the most current version of the FDA model food code.

7. Summarize the rule's content, and if this is an amended rule, also summarize the rule's changes.

Page 2 Rule Number: **3717-1-02.4**

This rule provides requirements for assignment of responsibility for the person in charge; requires food service operations and retail food establishments to have one manager that is certified in food protection; and the person in charge to demonstrate knowledge and ensure duties are being completed in their facility. Proposed changes include: replacing "One year after the effective date of this rule" with "As of March 1, 2017, each risk level III and risk level IV food service operation and retail food establishment shall have" and removed "shall" between "service" and "obtain"; split out the methods to determine demonstration of knowledge in (B) to paragraphs (1) and (2) and deleted the reference to having level two certification as a way to demonstrate knowledge; adding new section "Employees are properly maintaining the temperatures of time/temperature controlled for safety foods during hot and cold holding through daily oversight of the employees' routine monitoring of food temperatures;"; and replaced "shall have" with "has".
