O.A.C. 3701-1-03.1 is proposed to fulfill five-year review requirements. Also, Section 3717.05 of the Ohio Revised Code requires the Director of Agriculture and the Director of Health to adopt, amend, or rescind provisions in the Ohio Uniform Food Safety Code to ensure that it continues to conform to the U.S. Food and Drug Administration's Model Food Code. Changes are proposed to reflect the most current changes to the federal code.

The purpose of this rule is to provide the license holder of a food service operation or retail food establishment the requirements for sources of food offered for sale in their establishment. The proposed amendment will allow food processing establishments that are defined in rule 901:3-23-01(B) of the Administrative Code to be considered an approved source for pre-packaged juice.
