Food: protection from contamination after receiving.**RULE SUMMARY**

Section 3717.05 of the Ohio Revised Code requires the director of agriculture and the director of health to adopt, amend, or rescind provisions in the Ohio uniform food safety code to ensure that it continues to conform to the federal food and drug administration's model food code. The changes proposed are the result of the most recent changes to the federal code, and they fulfill five-year review requirements.

then summarize the content of the rule:

This rule sets forth license holders' responsibilities regarding preventing contamination of food after receiving it in their facilities. Changes include: correction of a typo and code references; lowering the temperature of the cooking of non-animal food that is contacted with bare hands; removal of language that prohibited the storing or displaying communitied meat above whole muscle intact cuts unless properly packaged; addition of new language to allow devices for use for on-site generation of chemicals used to wash raw whole furits and vegetables; clarification on linens and their use; and the rewording of the rule allowing for the refilling of returnables with food.
