This rule provides standards for protection of food from contamination after it is received. Proposed changes to the rule include: (K)(3) Removed "flour"; (K)(6) Removed "an"; (K)(7) Changed reference from 4.5(B)(2)(g) to 4.5(B)(4)(g); Removed regulatory restriction terms (shall, may not, prohibit, require).
