**Food: protection from contamination after receiving.****RULE SUMMARY**

6. State the reason(s) for proposing (i.e., why are you filing,) this rule:

Sections 3717.04 and 3717.05 of the Ohio Revised Code require the director of agriculture and public health council to adopt, amend, or rescind provisions in the Ohio Uniform Food Safety Code to ensure that it continues to conform to the Federal Food and Drug Administration's Model Food Code. The changes proposed are from the most current changes to the Federal Code.

of the proposed rule; If the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

This rule sets food handling procedures that food employees shall follow to prevent contamination after receipt. More significant amendments 1) allow ready to eat food to be handled with bare hands when added as an ingredient to a food that is to be cooked to required temperature; 2) allows frozen, commercially processed and packaged raw animal foods to be stored or displayed with frozen, commercially processed and packaged ready-to eat food; and 3) disallow storing and displaying comminuted or otherwise non-intact meats above whole-muscle intact cuts of meat unless they are packaged in a manner that precludes cross-contamination.

Facilities may obtain approval for food employees not serving highly susceptible populations to handle ready-to eat food with bare hands provided 1) it obtains prior approval; and 2) written procedures are maintained in the food service operation or retail food establishment and made available to the licensor upon request. Also, licensees must prepare a written employee health policy that details how the food service operation or retail food establishment complies with O.A.C. rule 3717-1-02.1; Food services and retail food establishments must document that food employees acknowledge that they have received training in: 1) risks of contacting the specific ready-to-eat foods with bare hands; 2) proper handwashing, including when and where to wash hands; 3) proper fingernail maintenance; 4) prohibition of jewelry; and 5) good hygienic practices. Food services and retail food establishments must also document 1) that employees wash their hands before food preparation, and as necessary, to prevent cross contamination during all hours of operation when the specific ready-to-eat foods are prepared; 2) that food employees contacting ready-to-eat food with bare hands use two or more additional safeguards listed in this rule; and finally 3) that the licensee document corrective action that is taken when requirements of this rule are not followed.
