Ohio Revised Code Section 3717.05 requires the Director of Agriculture and the Public Health Council to base the Ohio Uniform Food Safety Code, which is the statewide standard for food safety in food service operations and retail food establishments, on the most current version of the FDA Model Food Code. These amendments are to ensure that the Ohio Uniform Safety Code continues to conform with the FDA Model Food Code.

Content of this rule is limitation of growth of organisms of public health concern in food. Language changes have been made to conform to the current FDA Model Food Code (i.e. storage temperatures of food). Minimum hot holding temperature of potentially hazardous foods is changed from 140 degrees Fahrenheit to 135 degrees Fahrenheit. Necessary references to Ohio Revised and Administrative Codes and sections of the Code of Federal Regulations have been added.
