Content of this rule is identity, presentation, and on premises labeling of food. Language changes have been made to conform to the current FDA Model Food Code, to clarify labeling of fresh meet in retail food establishments, and to add/correct references to Ohio Revised and Administrative Codes and sections of the Code of Federal Regulations.
