Section 3717.05 of the Ohio Revised Code requires the director of agriculture and the director of health to adopt, amend, or rescind provisions in the Ohio uniform food safety code to ensure that it continues to conform to the federal food and drug administration's model food code. The changes proposed are the result of the most recent changes to the federal code and fulfill five-year review requirements.

The purpose of the rule is to provide the license holder of food service operations and retail food establishments the requirements for laundering the types of linens used in their facilities. Changes include; the clarification that napkins in this rule refers to cloth napkins and they are by definition considered linens.
