Content of this rule is plumbing systems. Minor language changes have been made to conform to the current FDA Model Food Code. A hand washing lavatory shall be equipped to provide water at a atemperature of 100 degrees Fahrenheit instead of 110 degrees Fahrenheit, as previously required.
