Ohio Revised Code Section 3717.05 requires the Director of Agriculture and the Public Health Council to base the Ohio Uniform Food Safety Code, which is the statewide standard for food safety in food service operations and retail food establishments, on the most current version of the FDA Model Food Code. These amendments or changes are proposed to ensure that the Ohio Uniform Food Safety Code continues to conform to the FDA Model Food Code.

This rule sets standards for the storage and disposal of refuse, recyclables and returnables. Language changes are proposed to conform to the 2005 Model Food Code and Supplement. Changes include technical corrections and terminology changes.
