The cost associated with this rule is the cost for a facility to maintain the physical condition: of the floors, walls and ceilings; shielding of light bulbs in food areas; installing and maintaining the heating, ventilation and air condition system vents as designed and installed according to the Ohio building code; installing and maintaining outer openings, overhead protection and outdoor areas. The costs for floors, walls and ceilings; installing and maintaining the heating, ventilation and air condition system vents as designed and installed according to the Ohio building code; and installing and maintaining outer openings, overhead protection and outdoor areas will vary depending on the condition of the facility. The Cost to shield the light bulbs in the food areas will range from \$3 to \$5 a piece for the tube type or \$1 to \$5 a piece for a shielded bulb.
