Because changes to the Model Food Code necessitated a review of the rules, the Director of Agriculture and the PHC are proposing amendments to OAC Chapter 3717-1 rules to either comply with the Code or to make minor technical corrections.

This rule sets the standards for the general maintenance of food service operations and retail food establishments.
