Ohio Revised Code Section 3717.05 requires the Director of Agriculture and the Public Health Council to base the Ohio Uniform Food Safety Code, which is the statewide standard for food safety in food service operations and retail food establishments, on the most current version of the FDA Model Food Code. These amendments are to ensure that the Ohio Uniform Safety Code continues to conform with the FDA Model Food Code.

Content of this rule is poisonous or toxic materials. Changes have been made to reference Chapter 921.06 of the Ohio Revised Code and to define "incidental use" of a general use pesticide.
