Ohio Revised Code Section 3717.05 requires the Director of Agriculture and the Public Health Council to base the Ohio Uniform Food Safety Code, which is the statewide standard for food safety in food service operations and retail food establishments, on the most current version of the FDA Model Food Code. These amendments or changes are proposed to ensure that the Ohio Uniform Food Safety Code continues to conform to the FDA Model Food Code.

This rule sets the standards for the custom processing of game animals, migratory waterfowl or game birds in food service operations and retail food establishments. Proposed amendments are added to clarify that products for custom processing in a food service operation and retail food establishment are not for sale.
