Further, costs for performing corrective actions that are not authorized by the fire marshal's rules are not reimbursable. In addition, language regarding non-reimbursable markup costs previously included in rule 3737-1-09.1 and language previously located in rule 3737-1-22 regarding the reduction in the reimbursable amount when the responsible person fails to comply with the Board's subrogation rule is being moved to this rule.
