As an on-going project Ohio EPA is evaluating emission control strategies for the control of ozone through VOC and NOx emission reductions. VOCs and NOx are precursors to ozone formation. The purpose of these new rules is to aid in the reduction of VOC emissions from consumer products so that measured ozone levels throughout the state of Ohio may be reduced to achieve and/or maintain the applicable 8-hour ground level ozone standard of 0.08 ppm as established by the U.S. EPA.

The draft rules under this Chapter will apply state-wide.

As part of the rule-making process, DAPC is required by Section 121.39 of the Ohio Revised Code to consult with organizations that represent political subdivisions, environmental interests, business interests, and others affected by the rules. The DAPC is offering your organization the opportunity to comment on these rules before the division formally proposes them.

Fiscal Analysis Chapter 3745-112 of the Ohio Administrative Code (OAC) "Consumer Products"

Background and general estimated cost of compliance to all affected persons:

The following analysis details the cost of compliance for affected parties with Ohio's new consumer product rules. These new rules include OAC 3745-112-01 thru OAC 3745-112-08. Consumer products include adhesives, aerosols, air fresheners, bug & tar remover, deodorants, wood floor wax, etc.

These rules are intended to help Ohio attain and maintain the 8-hour national ambient air quality standard (NAAQS) for ozone through the reduction of emissions of volatile organic compounds (VOCs) from these products. VOCs are a precursor to ozone. The rules specifically assist attainment of the standard in the 8 County Cleveland/Akron metropolitan areas, but are also applicable statewide.

Ohio's new proposed state-wide consumer product rules are based on the Ozone Transport Commission's (OTC) model rule that is currently in effect throughout various OTC member states in the northeastern U.S. Ohio specifically reviewed consumer product rules from the states of New York and Pennsylvania.

Ohio's consumer product rules are estimated to achieve a total VOC reduction in the amount of 21% based on projected uncontrolled limits. These reductions are necessary for Ohio's demonstration of attainment/maintenance of the 8-hr ozone NAAQS.

Cost of Compliance

Ohio EPA has evaluated the cost of compliance for regulated parties based on the Lake Michigan Air Directors Consortium (LADCO) & Midwest Regional Planning Organization (MRPO)'s Interim White Paper document for consumer products. The Interim White Paper describes available control technologies and their respective cost effectiveness. Cost effectiveness is the total annualized cost of control divided by the annual calculated emission reduction, expressed in dollars per ton. The White Paper study offers and accepts the OTC model rule, which includes the northeastern and Mid-Atlantic States down to Virginia. It is expected that manufactures of consumer products have already reformulated some of their product lines for sale in the OTC states.

The following is a list of the specific rules in this rulemaking effort with a brief discussion of the cost of compliance to all affected entities including, manufacturers, distributors, retailers, and consumers (including school districts, counties, townships and municipal corporations). This chapter affects a wide variety of regulated entities that

3745-112-01 Definitions

There is no cost of compliance associated with this rule. This rule contains definitions applicable to OAC chapter 3745-112.

<u>3745-112-02</u> Applicability

There is no cost of compliance with this rule. This rule outlines the applicability of the rules in OAC chapter 3745-112 to affected parties and presents exceptions to that applicability.

3745-112-03 Standards

There is a cost of compliance with this rule. The cost of compliance with this rule affects parties including consumer product manufacturers, distributors, and consumers. Costs to manufacturers are associated with research and development associated with reformulating consumer products, redesigning product labeling, and on-going testing to assure that coatings meet the requirements of this chapter. Costs to distributors and consumers include a pass-through markup of the initial costs of R&D and any additional costs for more expensive components needed for the reformulated consumer product lines.

The LADCO/MRPO's Interim White Paper estimates the cost to <u>manufactures</u> affected by the rule. The industries addressed by the White Paper are similar to industries found in Ohio and industries selling their products in Ohio. The White paper estimates the cost of compliance, as cost effectiveness, to be \$800 per ton of VOC reduced per year, which equates to an estimated \$7 million/year. The Interim White Paper does explain the items included within their cost effectiveness amount, which includes the capital and labor costs for reformulation and retooling to produce the new consumer products. It also includes the Indirect & Misc. costs for redesign of labeling, and product testing to assure that the consumer products meet the requirements of this chapter.

In order to estimate the potential increase in the cost per unit; the California Air Quality Board (CARB) calculated the projected annual costs divided by the number of product units sold to result in a cost per unit. Within the Interim White Paper it is estimated that the cost-effectiveness in dollars per pound of VOC reduced, and estimated cost in dollars per unit. When considering the cost increase <u>per piece</u>, it is estimated to range for \$0.00 to \$0.60 per piece,² with an average of approximately \$0.03 per piece.

It should be noted that Ohio's consumer product rules are based on the OTC model rule which has been in effect in several northeastern states, including New York and Pennsylvania, for many years. A similar consumer product rule is also in effect in the

state of California. Many of the national consumer product manufacturers have already developed reformulated consumer products for sale in these states that would meet the requirements of the state of Ohio; therefore, no reformulation costs will be required for these consumer products to meet Ohio standards.

3745-112-04 Exemptions

There is no associated cost to this rule. This rule specifies parties and products that are exempt from the requirements of OAC chapter 3745-112.

<u>3745-112-05</u> Administrative requirements

This rule specifies the general labeling requirements that are applicable to all consumer products listed in the Table of OAC rule 3745-112-03. However, Ohio EPA is only requiring small changes the manufacturers existing label; therefore, there are no estimated costs associated with this rule. Because manufactures already sell consumer products to the OTC states and California, it is assumed that their cost will not increase.

<u>3745-112-06 Reporting requirements</u>

This rule specifies the information that needs to be reported for all persons subject to the requirements of OAC Chapter 3745-112. Manufacturing facilities supplying consumer products in or into Ohio will be subject to this rule and will be required to comply with the reporting requirements set forth in this rule. Manufacturers will be required to keep records and, if Ohio EPA requests, the facility will have 90 days to produce them. The activities associated with the reporting requirements will result in a **personnel cost** only. Ohio EPA estimates this will require 20-40 hours of work per year at a rate of \$50 per hour or approximately \$1,000 to \$2,000. This rule will not result in any capital, operational, indirect or other cost. Furthermore, because manufactures already sell consumer products to the OTC states and California, it is likely that their cost, under this rule, will not increase.

3745-112-07 Variances

There is no cost associated with this rule. This rule specifies the procedures by which a person may apply for a variance from the requirements of OAC rule 3745-112-03.

3745-112-08 Test methods

This rule specifies the test methods and/or specific methodology that shall be employed to show compliance with the VOC contents of consumer products. There is a cost of compliance associated with this rule. The LADCO/MRPO's White Paper indicated that ongoing product compliance testing costs were included with the "cost per ton" cost effectiveness number discussed above for compliance with rule 3745-113-03.
