3796:2-1-03 covers the application review process and establishes the parameters of a scoring rubric that will be used to ensure a fair and unbiased review of the applications submitted for cultivator licenses. This rule also establishes certain requirements that must be met for an application to receive consideration and identifies bonus criteria to consider during the review process.
