3796:2-2-01 details the components of a quality assurance plan and establishes standards with which cultivators must comply to ensure product consistency and patient safety. This rule includes limits on pesticide and fertilizer usage, equipment cleanliness, facility sanitation and other quality assurance considerations. This rule also includes language around the cultivator#s operations plan that will help them comply with the various requirements imposed by law and rule, including cleanliness and sanitary environment standards.
