Page 2 Rule Number: 3796:2-2-03

3796:2-2-03 addresses the different ways a cultivator can dispose of medical marijuana waste and non-medical marijuana waste, including rendering it unusable in a locked dumpster or composting the waste on-site for future use on-site. The rule lists the material that can be mixed with the waste to render it unusable pursuant to the rule. It also requires that a Level I key employee oversee all waste disposal and destruction documented in a destruction log maintained by the facility and submitted to the Department.
