3796:2-2-06 lists the testing requirements depending on the intended use of the plant material. If the plant material is being shipped directly to a dispensary for patient administration, a much stricter lab analysis is required. If the plant material is being sent to a processor to be refined and extracted, then the product will undergo subsequent tests and the analysis for this material will be reduced. The industry will impose its own set of requirements. Testing laboratory standards will be detailed in future rules.
