3796:5-2-01 addresses required employee identification cards and includes the application process, issuance of the ID card, employee designations for facility access purposes, and the revocation of a card and/or entity license that employs the person.

RSFA question #5 was updated to designate a more specific statute that the rule amplifies. Language was added to paragraph (A) to include any "other person who may significantly influence or control the activities of" a cultivator, processor, or testing laboratory on the list of individuals who must apply for an employee identification card.
