There is a license required to operate as a medical marijuana entity in the state of Ohio. Additionally, the rule requires that transportation take place in the presence of two registered employees. Employee registration and the associated ID cards require payment of a \$100 fee.

The rule requires the presence of two registered employees during medical marijuana transportation. It also requires the upload of manifest data into the seed-to-sale tracking system.
