The proposed amendments to the rule will fix an error in reference that is present throughout the rule. This will correct references for 3903.72.1 and 3915.07.1 to 3903.721 and 3915.071. Also, per department formatting, technical changes will be proposed to the Authority, Purpose and Severability clauses.

This rule establishes minimum standards and reserves and nonforfeiture values for pre-need life insurance contracts based on the study that determined the 2001 CSO was inappropriate for determining reserves for policies used to fund funeral services and expenses.
